### BURSARIES FOR UNDERGRADUATE ELECTIVE VACATION STUDIES

The Pathological Society of Great Britain & Ireland is offering a number of bursaries to undergraduate students of medicine, veterinary medicine, dentistry or biomedical science to enable them to work for elective or vacation periods in departments of pathology in universities, medical schools, NHS laboratories or research institutes in the United Kingdom or overseas.

Proposals for work on research projects in any branch

of pathology or for the acquisition of experience in diagnostic departments are eligible for consideration. Such work should normally be sponsored by a Member of the Society. Application deadlines: **31 January, 30 April, 31 July and 31 October** each year.

### CAREER DEVELOPMENT FELLOWSHIP

The Pathological Society's 'Career Development Fellowship' is designed to offer support for continuing research over a 2-year period by academic trainee pathologists following the award of a PhD or MD, when progressing through the final stages of their histopathological training leading up to the award of CCT. Bridging this period from completion of PhD/MD to completion of CCT, the Pathological Society can offer research support by way of one Fellowship per year. Application deadline: **1 April** each year.

### EDUCATIONAL GRANT SCHEME

The Educational Grant Scheme was introduced in 2008 to support a range of activities in the performance, development and assessment of undergraduate and postgraduate education in pathology. Such activities may include:

- (a) Organisation of educational meetings
- (b) Promotion of pathology in undergraduate and postgraduate education, both medical and non-medical
- (c) Development of educational tools, for example e-learning software / databases
- (d) Support for networks of pathologists involved in pathology education

Salaries and support of specific research proposals are excluded from this scheme. **Applications are invited from Members of the Society of at least 12 months standing.** The closing dates for applications are: **1 April and 1 October** each year.

### VISITING FELLOWSHIPS (formerly 'Fellowships')

The Society sponsors a number of Fellowships to enable members of the medical and allied professions working in the UK or Ireland in pathologically-related biomedical research to travel to other institutions for periods of up to 12 months to learn new techniques of value in their clinical and/or laboratory research. The closing dates for applications are: **1 April and 1 October** each year.

### INTERCALATED DEGREES IN PATHOLOGY

The Society provides an annual sum for up to six medical, dental or veterinary undergraduates who wish to take an Intercalated Degree (either BSc or MRes/MSc) but who are unable to do so because of lack of local education authority funding. Applicants must provide details of syllabus and infrastructural support arrangements.

For 2011 the scheme was changed to allow applications for students and institutions. Offers must be taken up either in the year allocated or in the succeeding year. The deadline application is **1 March** each year.

### OPEN SCHEME

This scheme supports a range of additional activities, all of which share one common aim, namely to support the

Society's Mission Statement. **Applications are invited from Members of the Society of at least 12 months standing.**

The closing dates for applications are: **1 March, 1 June, 1 October** and **1 December** each year.

#### **PATHOLOGICAL SOCIETY MEETINGS BURSARIES**

*(formerly known as 'Conference Bursaries')*

A number of bursaries will be made available to cover the cost of registration fees for Society Members who are post-graduate students (PhD, MD or MSc) and wish to present their research at Society meetings. An applicant whose work is/has been selected for presentation in a plenary session will be favoured. Application deadlines: **1 June** and **1 November** each year.

#### **PhD STUDENTSHIPS**

The Society provides a PhD sponsorship scheme.

Applications are invited from **established Members of the Society (membership of minimum 12 months) who wish to act as supervisors** of a project which will lead to the award of a PhD for the student carrying out the work under their supervision. The closing date for applications for commencement of a project in 2012 is: **1 November 2011**.

#### **SMALL GRANTS SCHEME**

This scheme has been established particularly to encourage Specialty Trainees (or Honorary Specialty Trainees) in Histopathology or to undertake investigative research. The

grant is intended to be used for re-agents or contribute towards a piece of equipment for research to underpin a project(s). The Society will support research which will lead to publications in peer-reviewed journals and/or to the award of a higher degree. The closing dates for applications are: **1 April** and **1 October** each year (*note new deadlines*).

#### **TRAVEL AND CONFERENCE BURSARY**

*(formerly known as 'Travel Awards')*

This scheme was introduced in 2004 to encourage and promote scientific communications at major international meetings. **The Society meetings are excluded from these awards.** Applications are invited from established Members of the Society (**membership of minimum 12 months**). Members who are in substantive NHS consultant, academic or similar permanent positions are **ineligible** for this Scheme. Applications are reviewed on an on-going basis and may therefore be submitted at any time.

5.1 Notice of proposal to amend Rule Numbers 9 and 11

The Committee propose the amendment of Rule Nos. 9 and 11 as below in order to adjust the number of Ordinary Members who come up for election each year, as the 4 per year rule was a residual figure left over from the days when the microbiologists were in membership (until 2001).

Rule No 9 – Current wording

Each year the four Ordinary Members of the Committee, senior in order of election, shall retire from office after a 3-year term and shall not be eligible for re-election till one year has elapsed after their demission from office. Names of Members to serve on the Committee may be proposed by any Member who has obtained the written consent of the nominee, such nominations to be sent to the General Secretary at least three months before the Annual Business Meeting.

Proposed new wording – *changes are italicised*

*Each year the Ordinary Members of the Committee whose terms of office have expired* shall retire from office and shall not be eligible for re-election until one year has elapsed after their demission from office. *There shall be up to 12 Ordinary Committee Members in office each year.* Names of Members to serve on the Committee may be proposed by any Member who has obtained the written consent of the nominee, such nominations to be sent to the General Secretary at least three months before the Annual Business Meeting.

Rule No 11 – Current wording

The Society shall, from the names submitted to it, select by ballot four Members to fill the vacant places. In the case of any incidental vacancy occurring in the Committee this shall be filled up at the next Annual Business Meeting by the election of another Member. This Member shall only hold office for the remainder of the period of office of the Member whose place he/she takes and shall be eligible for re-election.

Proposed new wording – *changes are italicised*

The Society shall, from the names submitted to it, select by ballot *Members to fill the vacant places*. In the case of any incidental vacancy occurring in the Committee this shall be filled up at the next Annual Business Meeting by the election of another Member. This Member shall only hold office for the remainder of the period of office of the Member whose place he/she takes and shall be eligible for re-election.

- 4. President's Report.**

*(Prof AH Wyllie)*

  - 4.1 Priorities for the Society.**

The President reported on the continued success of the *Journal of Pathology*, the Grant Schemes available to facilitate a research career, the Winter and Summer Scientific Meetings and Winter and Summer Schools. Concern was raised regarding decrease in the NHS funding for health service professionals and University funding which would lead to undergraduate students seldom/never coming into contact with a pathologist throughout their education.

The General Secretary thanked the President for his report.

*(Prof CS Herrington)*

  - 5.1.1 The Jeremy Jass Prize.**

This prize would be awarded by the Editorial Board of the *Journal of Pathology*. The next award will be made in January 2011.

*– nomination deadline 1 October 2010*  
Attention was drawn to the earlier deadline date of 1 October as the 2011 Summer Scientific Meeting would be taking place at the earlier time of 10–13 May 2011. Nominations for 2011 were requested
  - 5.1.5 Ritchie Medal.**

*– nominations accepted at anytime.*  
Nominations for 2011 were requested.
  - 5.2 Membership.**
    - The membership numbers have stabilised and are currently higher than in previous years.
    - A large proportion of the membership increase was due to Concessionary Members.
    - It was important that Concessionary Members convert to Ordinary Members although it appeared that this was spontaneously happening.
  - 5.3 Website and Publications Strategy Group.**
    - The website had undergone an upgrade in the last 12 months resulting in an improved Educational and Research portal. Video lectures were now on the website along with the virtual slide classroom.
    - *The Matter of Life and Death: Conversations with Pathologists* had been republished and rebranded by Canongate and was currently on sale from Amazon.
    - Feedback on the collections of interviews with prominent pathologists (*Conversations with Pathologists*), now available on the Society website, was encouraged.
  - 5.4 Irish Republic – change of representative.**
    - A vacancy existed following the retirement of Prof Grace Callagy as the Irish Republic representative. Prof Elaine Kay would be taking over the role of the Irish Republic representative commencing July 2010.



- Prof Grace Callagy was thanked for her work during her time as the Irish republic representative.

## 5.5 Other matters.

No further matters were reported.

## 6. Treasurer's Report and Appointment of Auditors. (Prof AD Burt)

### 6.1 Review of the Year 2009.

The Treasurer referred to his report which had been published on the website prior to the meeting.

- The full accounts were now available on the Society's website.
- The investment portfolio is currently in excess of £6 million pounds.
- The increase in 2009 is in part due to the rebound in the financial markets but more substantially due to the increased income from the *Journal of Pathology*. The profit share has now increased from 55% to 65%. 2010 will see a further increase to 70%.
- Income on investments declined due to poor returns from the low interest rate of those resources held as cash.
- Expenditure for 2009 showed a slight decrease due in part to the completion of the Centenary Clinical Fellowships awarded in 2006 from the Centenary Splash funds.

Questions were invited – there were none.

### 6.2 Investment Management.

- The Society had recently put the investment management portfolio out to tender.
- Cazenove, UBS, and Shroeders had all made presentations.
- It had been decided to retain Cazenove as the Investment Management company for the forthcoming 12 months.
- The Investment Management provision would be reviewed in 2011.

### 6.3 Grant Scheme budgets.

The expenditure for 2010 was attached to the website overview. The 2010 budgets included an additional £10,000 for a Public Engagement Scheme, a new Grant Scheme for 2010.

### 6.4 Accounts for the year ended 31.12.09 – to seek acceptance and approval.

The proposal to accept the accounts was made by Prof P Quirke, Leeds and seconded by Prof S Fleming, Dundee.

### 6.3 Appointment of new Accountants and Auditors.

- The account and auditing support for the Society had been put out to tender in 2010.
- Four companies, all with experience in the Charity sector, had bid for the accounts and audit work.
- It had been decided, after a convincing

presentation and positive references, to move from Menzies, our present accountants to Alliotts.

The proposal to appoint Alliotts as the new accountants and auditors was proposed by Prof A Wyllie, Cambridge and seconded by Prof S Fleming, Dundee.

### 6.6 Proposal for 2011 subscriptions.

Subscriptions would remain the same for 2011.

- Ordinary subscription £53.
- Subscriptions for Ordinary Members with Concessionary status £10.
- *Journal of Pathology* subscription £59.
- Diagnostic Histopathology £100

Questions were invited – there were none.

The General Secretary thanked the Treasurer for his report.

## 7. Meetings Secretary's Report

(Prof IO Ellis).

Details of future meetings were given in the full briefing document.

### 7.1 Cardiff Pathology 2009.

Feedback indicated this was a highly successful meeting with 423 delegates and 224 submitted abstracts. Six videoed lectures are available to view on the Member's area of the Society's website. Thanks were given to Professors Williams and Jasani.

### 7.2 2010 Winter Meeting, Imperial College, London.

Despite heavy snowfall only 10% of delegates did not attend the meeting. In total there were 161 delegates and 101 submitted abstracts. Two videoed lectures are currently available to view on the Member's area of the Society's website. Thanks were given to Professors Stamp and Thomas.

### 7.3 Future Meetings.

#### 7.3.1 2011 Winter Meeting, Cambridge.

The meeting is to be held at the Hinxton Campus and will be educationally focused with 8 plenary presentations and poster sessions.

#### 7.3.2 Ghent Pathology 2011 (6<sup>th</sup> Joint Meeting with the BDIAP), 10–13 May.

The meeting will take place in a converted monastery at the earlier time of May. A mixture of disease and organ site specific symposium promised an interesting meeting.

Questions were invited.

Prof P Quirke enquired whether detailed statistics were available of the abstract submission and delegate attendance at Society meetings and if any trends had been identified. The Meetings Secretary confirmed that some information is available in the Society's Annual Report however the level of detail was limited as the Society's meeting software did not facilitate such an audit.



The General Secretary thanked the Meetings Secretary for his report.

## 8. Sub-Committees – Chair’s Reports.

### 8.1 Education and Training Sub-Committee.

(Dr EW Benbow)

#### • Undergraduate Elective/Bursary Awards.

A record number of applications for Undergraduate Elective Bursaries had been received in April leaving 15 bursaries unfunded. Students had been referred to the ACP and BDIAP to seek funding. Links with these organisations are proving fruitful.

#### • Undergraduate Prize Essay Competition 2010.

Fourteen essays had been received and were currently being reviewed.

#### • Intercalated Degree.

In 2011 the six annual awards will be distributed differently. Three of the awards will be allocated to a University department and three awards will be allocated directly to the student. This new method of distribution is a pilot and will be reviewed after the 2011 allocation.

#### • Educational Day.

The first Educational Day is due to go ahead at the Royal College of Pathologists on 17<sup>th</sup> November 2010 and is aimed at updating diagnostic pathologists about what they need to know about molecular pathology.

Questions were invited – there were none.

The General Secretary thanked Dr Benbow for his report.

### 8.2 Research Sub-Committee.

(Dr MJ Arends)

#### • Small Grants Scheme.

Five of the eight applications received since July 2009 were funded.

#### • Fellowship.

No Fellowship applications had been received since December 2008. Members were encouraged to draw attention to this grant scheme within their departments.

#### • Sino-European Collaborative Award.

The Sino-European Award will continue for another 3 years following the success of the previous 3 years.

#### • Japanese Collaborative Award.

The Japanese Collaborative Award has been relaunched following a poor initial uptake. Two applications had been received in the 2010 round of applications, both of which would be funded.

#### • Career Development Fellowship.

This scheme is new for 2010. One application was received and awarded to Dr A Jubb.

Questions were invited – there were none.

The General Secretary thanked Dr Arends for his report.

### 8.3 Trainees’ Sub-Committee.

(Dr I Proctor)

• Dr Proctor thanked Drs Bury, Christian, El Daly, Le-Quesne and Treacy, for their work on the Sub-Committee. Drs Bury, Christian, El Daly, Le-Quesne and Treacy retire from the Sub-Committee July 2010.

#### • Meetings.

Meet the Expert Sessions, Trainees Symposia and Trainees Breakfast Meetings are currently a successful part of the Winter and Summer Society meetings.

#### • Trainee Questionnaire.

The Trainee Questionnaire will be recirculated to Concessionary Members to ascertain those trainees who are interested and/or engaged in research in an attempt to promote the activities of the Society to trainee pathologists.

#### • Website.

It was felt that in the past the website had not been fully utilised. A ‘Case of the Month’ aimed at engaging more trainees is now ready to be launched.

Questions were invited – there were none.

The General Secretary thanked Dr Proctor for his report.

### 9. Journal of Pathology, Editor’s Report.

(Prof PA Hall)

#### • The Impact Factor

The Impact Factor had recently been published and was at an all time high of 6.466, representing the culmination of an upward trend over the past ten years.

#### • The Sims-Woodhead Medal.

The Sims-Woodhead medal was awarded and presented to Prof CS Herrington by Prof PA Hall for his contribution to the *Journal of Pathology* throughout his tenure as Editor-in-Chief.

Questions were invited.

Prof A Wyllie enquired as to the origins of authorship. Prof PA Hall answered that there was an increase in the number of submissions from North America and Asia with a decrease in the number of UK submissions. A growing area was multi-national submission.
