Minutes of the Annual General Meeting of the Pathological Society of Great Britain and Ireland held in Gallery 1, East Midlands Conference Centre, University of Nottingham, University Park, Nottingham at 13.00 hours on Thursday 30 June 2016.

The Annual General Meeting Agenda document and ballot papers had been circulated to most Members by e-mail and sent by post to those Members without e-mail addresses and who had indicated a preference for paper mailings. With the aim of achieving a timelier meeting, a document ("Overview of the Year") had been posted only on the Society's website. This document is available by post to those Members who request it. The Society will do everything possible to support its Members.

The General Secretary welcomed all those present and drew Members' attention to the *Annual Overview* which had been published on the Society's website.

 Minutes of the Annual Business Meeting of the Pathological Society of Great Britain and Ireland, held on 25 June 2015. The minutes were accepted by the meeting.

The minutes were accepted by the meeting. Proposed by Prof AM Flanagan and seconded by Prof MJ Arends.

- 2. Matters arising from the Minutes. There were none.
- 3. Elections.

The results were announced at the end of the meeting (see item 10 on page 11).

3.1 Education and Training Sub-Committee Chair-Elect.

One nomination had been received.

3.2 Ordinary Committee.

Originally there were three vacancies however a fourth had arisen due to the resignation of Prof JA Hoyland which, therefore four vacancies existed and five people had put themselves forward.

3.3 Trainees' Sub-Committee Members. There were four vacancies and four candidates standing for election.

- 3.4 Ballot papers had been circulated to Members and those present who hadn't yet voted were asked to hand their votes to the Deputy Administrator before the end of the meeting. This also gave the opportunity for any Members to raise objections, should they wish.
- 4. **President's Report.** (*Prof P Quirke*)

4.1 FGP Strategy.

Noted:

- i. It's been a busy year, we have a new strategy which will be updated annually. We will have an annual strategy meeting to do so and hopefully the progress we make will change the environment of pathology. We have active Undergraduate initiatives with the Joint College Meeting, a stand-alone Pathological Society Undergraduate Meeting and we will hopefully move to 3-a-year in the very near future. We have introduced Undergraduate Membership (Richard Byers), in conjunction with Suzy Lishman, RCPath President.
- The third National Academic Trainee ii. Network Meeting was held on Sunday/ Monday this week, with more planned in October and January. We need to get more people into pathology research fellowships to generate successful PhD research fellowship applications. We have created with the College a potential new pathway. We wish to co-fund up to five six-month research fellowships per year which with the research module of the RCPath training would generate nine months training minimum. This will cost us £100,000 per year. The details will be published in September. Hopefully this will double or triple the number of academic fellowships available within the UK.

Questions were invited:

i. It may be tricky getting OOPR permission. Peter Johnston PQ agreed this may be an issue in devolved nations but the trick was to ask well in advance (6–12 months) so people need to think early about this option. Aim to get one-third going forward as academic clinicians.

4.2 Links with other Professional Bodies. Noted:

i. Japan, China and India.

- To date we have had links with Japan, China and we have discussed forming links with India.
- ii. **Europe**. We are tr
 - We are trying to develop and reinforce links with our European colleagues and will try to amalgamate our academic trainee meetings in Europe.
- iii. Members are encouraged to attend the 2017 Winter Meeting which we consider an important part of our research activity and community, and for consultants to link up with trainee academics.

iv. Royal Society of Medicine.

The 2018 Winter Meeting may be a joint meeting with the Royal Society of Medicine. The Pathological Society has historical links with the Pathological Society of London and the Royal Society of Medicine, and Members were asked to support the re-establishment of that link by attending the meeting.

v. **BDIAP.**

We continue to meet with the Officers to discuss our own respective priorities.

vi. RCPath.

We have a great relationship with the current President. However they seem to have more resources issues at present and so can be on minimal financial help.

vii. NIHR.

Developing the relationship with the new Dean of NIHR which is important if we are to increase the number of ACF positions.

4.3 ACCEA.

Noted:

- i. The Society continues to offer support to Members and citations and rankings had been submitted following consideration by the review panel, which comprises the four key Officers and one lay representative and it is important to support academic pathology.
- ii. The Society is able to submit citations for the vast majority of applicants.
- iii. The President thanked the Officers for writing citations.

4.4 Other matters.

i. The President thanked Nick Rooney for all his work during his time as Treasurer and Liz Soilleux as Education Sub-Committee Chair (she will be retiring in June 2017).

The General Secretary thanked the President for his report.

5. General Secretary's Report. (Dr RJ Byers)

5.1 Society Lectures, Medals and Awards. Call for nominations. Noted:

Nominations accepted at any time. Only one award has been made since introduction and Members were encouraged to consider suitable candidates for this. This award is in honour of the First General Secretary of the Society and is given to long-standing Members who have made outstanding services to pathology or the Society. The second medal has been awarded to Prof Ian Ellis and will be presented at the Conference Dinner this evening and we would like to congratulate Ian for his achievements.

5.1.5 New "Wright" Medal.

This objective of the new medal is to reward and recognize the scientific achievements, in particular, of trainee histopathologists and to recognize and increase the spread of awareness excellent work being done by young academic pathologists. Prof Sir Nicholas Wright has granted us permission to do this and we would like to initiate this next year.

5.2 Membership.

Noted:

- i. Membership continues to grow with an increase from 1660 to 1785 since last year and includes 280 undergraduates.
- ii. Since the last Annual General Meeting the Committee had been informed of the deaths of the following members (listed below). The Committee stands for a minute's silence at Committee meetings.

5.3 Associate Undergraduate Membership. Noted:

- i. This is proving popular and is growing. We had a very successful Undergraduate session at this meeting on Tuesday, with Phil Quirke, Suzy Lishman and Nick West giving talks.
- ii. The Undergraduate Network goes from strength to strength and they have published an *Annual Review* which has been available for delegates this week.

5.4 Website and Publications Strategy Group. Noted:

i. The website has not progressed due to the constraints and problems with 3Si, which has proven to be not fit for purpose despite the hard work and efforts of Julie Johnstone and Ros Pitts.

5.5 Other matters.

Noted:

i. The publication of the *Journal of Pathology* and *Journal of Pathology*, *Clinical Research*, continues successfully.

Questions were invited – there were none.

6. Treasurer's Report and Appointment of Auditors. (*Dr N Rooney*)

6.1 Review of the Year 2015.

The Treasurer referred to his report which had been published on the website prior to the meeting. Noted:

- i. Income was approximately £1.17 million comprising return on investments, £86,886 from subscriptions and £690,336 from the *Journal of Pathology* profit share.
- ii. Expenditure: £614,000 on grants and £196,000 on Meetings.
- iii. The Society's running costs are £360,476.
- iv. We still have substantial reserves however the Society should spend its income wisely.
- v. To protect the impact and immediacy factor of the Journals, the Society had employed Richard Poulsom as full-time Scientific Editor. The Society covers two-thirds of the cost and Wiley covers one-third.
- vi. The Society has moved office to much better accommodation in the the Minories, which is very close to the College temporary premises and the new building.
- vii. The Society pays commercial rent which is shared one-third by the BDIAP. There are three workstations. The College could not offer us the space we required within their temporary office building.

- viii. Future accommodation in the new College building – we are exploring this either by long term rental or capital investment options The College would like the Society office to be in their building.
- ix. The solicitors advise we perform an annual audit to comply with charity commission guidance. Legislation is prescriptive, Trustees are no longer given the benefit of the doubt.
- x. Terms and Conditions of Membership will be reviewed and updated and sent out to Members.
- xi. Our database had been moved to the 3Si platform which is secure, backed up and is off site, however it's an extremely complex system which has proven rather cumbersome and we will be exploring other options but will continue to run with it for the next year.
- we plan to update the Society strapline to "Understanding Disease – Guiding Therapy" to include emphasis and inclusion of the new Journal "Journal of Pathology, Clinical Research". Applications for updated trademarks will be submitted.

Questions were invited – there were none.

6.2 Investment Management.

Noted:

- i. Cazenove give a written and verbal review annually at our January committee meetings including a comparison with other fund managers.
- ii. They are now part of the Charity Division of Schroders.
- iii. We have a balanced portfolio, it has taken a 1% hit last Friday, following the UK referendum outcome to leave the EU.
- iv. We continue to have regular phone calls and updates with Jeremy Barker.

6.3 Grant Scheme Budgets.

- Noted:
 - i. All worthy applications are funded.
 - ii. The Small Grant Scheme was expanded into three schemes, namely, "Trainees", "Consultant's Pump Priming Scheme" and "Post-Doctoral Collaborative" and have increased the total available for these schemes to £120,000.
 - The Seminars for Student Scheme has been rebranded the "Student Society Bursary Scheme" and the applications are managed by the Undergraduate Committee, who are in turn supervised by the Officers.

Questions were invited – there were none.

6.4 2017 Membership Subscriptions. Noted: The proposed fees for 2017 will be: i. Ordinary — £60 (no increase) Concessionary — £10 (no increase) Journal of Pathology — £45 online only, On-line + print £65 Diagnostic Histopathology — £120 online

only. This will be withdrawn as the Society is liable to pay VAT on this. Diagnostic Histopathology, online + print £143

- 6.5 Accounts for the year ended 31.12.15 — for The Pathological Society, to seek acceptance and approval. Noted:
 - The two-page abbreviated accounts had been i. circulated with the Agenda.
 - Dr N Rooney proposed the accounts be ii. accepted and Prof GI Murray, seconded the proposal.

 - Our current accountants and auditors, i. Alliotts, had provided a variable quality of service over the past year.
 - ii. The proposal to re-appoint Alliotts was made by the Treasurer and seconded by Prof GI Murray

- We had received the final payment of £37,000 ii. from CPO Hanser now that the VAT had been finalized which was transferred by Gift Aid to the Society.

6.8 Other matters.

Noted:

- As a Charity we are not permitted to receive i. in excess of £50,000 pa in commercial income. Should this happen, we may need to consider keeping PL2014 open and changing the name to Path Soc Trading.
- ii. The Treasurer thanked Ros Pitts and Julie Johnstone for supporting the Society and dealing with his late emails!

Questions were invited - there were none.

The General Secretary thanked the Treasurer for his report and thanked him on behalf of the Society for all his work over the past five years, and steering the Society through stormy waters.

- 7. Meetings Secretary's Report. (Prof AM Flanagan)
- 7.1 2016 Winter School and Future Winter Schools. Noted:
 - i. This school, now run by Dr Catherine Horsfield and Dr Ali Winstanley continues to be successful. It was oversubscribed in 2016, possibly due to the fact that the Society reduced registration fees for Society Members.
 - ii. We had asked for the school to have a new format with an emphasis on molecular pathology. We are not trying to compete with the BDIAP course.
 - iii. Financially it incurs a small loss but we hope to reduce that.

7.2 2016.

- 7.2.1 Winter Meeting, London, 7–8 January 2016. Noted:
 - i. No report was given.
- 7.2.3 Nottingham Pathology 2016, 8th Joint Meeting with the BDIAP, 28 June-1 July 2016. Noted:
 - The Meetings Secretary thanked Professors i. Ellis, Ilyas and Rakha and their colleagues for a great meeting, which had attracted around 460 delegates.
 - ii. The presentations went very well.

7.3 2017.

 - i. 2017 Winter Meeting - this would be a stand alone Path Soc smaller meeting. Prof Jo Martin and Prof Sir Nicholas Wright had agreed to host this. It had been agreed that we run this meeting in 2017 despite the significant financial loss to the Society.

- i. The Meeting is being hosted by Prof Manuel Salto-Tellez and Dr Maurice Loughrey and the programme planning is coming along well.

 - Prof Heike Grabsch and her colleagues in i. Maastricht had agreed to host the meeting and a site visit will take place soon.

8. Sub-Committees – Chair's Reports.

8.1 Education and Training Sub-Committee. (Prof EI Soilleux)

Noted:

- i. Members were referred to the report which had been published on the website prior to the meeting for a full update.
- ii. Grant Schemes, we had funded 21 out of 27 undergraduate bursaries, and we give a prize for the best report.
- iii. The 2015 Undergraduate Essay Competition, which a prize of £500 was won by Marcos Narajos, Oxford title: "Both clinical and academic pathology are becoming increasingly interdisciplinary. Discuss".
- Details of 2016 Essay Competition were on the website – members were encouraged to promote this amongst their students.
- v. Intercalated Degrees, we funded 8 out of 11, a smaller number than last year.
- vi. Seminar for Students (rebranded "Student Society Bursary Scheme") is now managed by the Undergraduates.
- vii. Education Grant, received few applications.
- viii. Winter School programme will have a more molecular focus, and we have increased the subsidy on registration fees to make this more popular.
- ix. This year we are keen to interact with students and trainees. We are trying to increase the number of molecular pathologists.
- x. We are endeavouring to get more molecular pathology into the curriculum and have been writing online molecular pathology modules and will move this forward.
- xi. We have introduced the Ambassadors scheme across the UK and hopeful it will extend to Ireland.
- xii. Prof Soilleux welcomed Dr Emyr Benbow as the Chair-Elect.

Questions were invited - there were none.

The General Secretary thanked Prof Soilleux for her report.

8.2 Research Sub-Committee. (*Prof MJ Arends*) Noted:

- i. The purpose of the Sub-Committee is to support the research aims of the Society. In summary the grants over the past year are:
- ii. The original Small Grants Scheme, one in Nottingham and one in Sheffield.
- iii. The Joint Pathological Society / Jean Shanks Foundation Research Training Fellowship is one of the most hotly contended schemes and we funded an excellent application from Oxford.
- iv. Career Development Fellowship supports two awards annually, and these were awarded to Leeds and Nottingham.
- v. International Collaborative Award, two applications were supported one for a collaborative between Sheffield and Ibadan, and one between Leeds and Linkoping.
- vi. Visiting Fellowship one application was supported.
- vii. Our future strategy includes engagement with CMPath.
- viii. The Society had funded a Animal Mouse Model Pathology Course in 2016 the next one will be held in 2018.
- ix. Prof Arends thanked Julie Johnstone for all her hard work and efforts.

Questions were invited – there were none.

The General Secretary thanked Prof Arends for his report.

- 8.3 Trainees' Sub-Committee. (Dr G Petts) Noted:
 - i. The Trainees' Sub-Committee is working to facilitate trainees to undertake research.
 - ii. We continue to update Twitter and now have 777 followers.
 - We continue to work with the Education Sub-Committee and have assisted with setting up the Case Report Prizes and Ambassadors Scheme.
 - iv. We continue to work with the Meetings Secretary and our BDIAP counterparts.
 - v. The Trainees sessions this week on MDT and Sessile Lesions were great and Dr Petts thanked all the speakers for their lectures.

- vi. We fully support the major source of funding provided by the Research Sub-Committee.
- vii. The National Academic Trainee Network Meetings, which the trainees appreciate and it offers experience and didactic sessions and a great networking opportunity.
- x. Dr Petts thanked the outgoing Members of the Sub-Committee for all their amazing hard work over the past three years.
- x. We are looking forward to working with the new Sub-Committee Members.

Questions were invited – there were none.

The General Secretary thanked Dr Petts for her report.

9. Editor's Report – Journal of Pathology and Journal of Pathology: Clinical Research. (Prof CS Herrington)

9.1 Review of the year.

Noted:

- i. The New Impact Factor had just been released, 7.381, just a little lower than last year at 7.429. We are reasonably comfortable with this, however not complacent.
- Richard Poulsom has made a huge difference to driving quality control and Simon thanked Richard for his input.
- iii. The ARI on Genetics and Disease will be published in January. Prof Herrington thanked Prof Mark Arends, Bruce Whitelaw and Eric White as Guest Editors.
- iv. Open Access (OA), an EU directive, states that everything must be Open Access by 2020.
- v. Wiley had produced a position statement, but following Brexit it might be irrelevant.
- vi. OA is becoming much more important. We have kept a watching brief but it is starting to ramp up and we would need to charge a lot of money to maintain.
- vii. Richard Poulsom is screening all figures and the anomaly rate is approximately 10%.
- viii. We have had a couple of retractions recently. Some Committee Members will be aware of *Retraction Watch*, as we had featured in one of their articles earlier in the week.
- ix. Similarly we would reduce the number of "dodgy" figures.
- x. IF for Oncogene and Modern Pathology have taken quite a hit and *American Journal of Pathology* continues to nosedive.

- **9.2** Journal of Pathology: Clinical Research. Noted:
 - i. The *Journal* is making steady progress, with six issues published and sufficient copy for the remainder of the year.
 - ii. Approximately 25% of copy comes from offer of transfer from the *Journal of Pathology*.
 - iii. We are now listed on *PubMed* and we should be on *PubMedCentral* soon.
 - iv. Journals need to publish for two years before getting an IF.
 - v. We are cautiously optimistic and we have a reasonable amount of material in the pipleline. *PubMed* listing is retrospective.
 - vi. NR reminded Members that the Society offers a publication grant for JPCR but we have spent very little of our budget. CSH stated that a lot of institutions now fund OA fees themselves.

9.3 The Jeremy Jass Prize for Research Excellence. Noted:

i. The prize goes to one of the top-cited articles in the *Journal of Pathology*. The Prize was presented at the Society's Winter Meeting this year.

Questions were invited - there were none.

The General Secretary thanked Prof Herrington his report.

10. Election Results.

3.1 Chair, Education and Training Sub-Committee. Noted:
