The Ritchie Medal shall only be awarded on those occasions when a particularly outstanding and deserving recipient can be identified. Nominations will be made in the form of a 500 word Citation by any Member of the Society to the General Secretary and *may be made at any time*.

### **Minutes**

### The Pathological Society of Great Britain and Ireland ("Pathological Society")

Minutes of the Virtual Annual General Meeting of the Pathological Society of Great Britain and Ireland held at 13.00 hrs on Thursday 8 July 2021.

The Annual General Meeting Agenda document and ballot papers had been circulated to most Members by e-mail and sent by post to those Members without e-mail addresses and who had indicated a preference for paper mailings. With the aim of achieving a timelier meeting, a document ("Overview of the Year") had been posted only on the Society's website.

This document is available by post to those Members who request it.

The Society will do everything possible to support its Members.

The General Secretary welcomed all those present and drew Members' attention to the *Annual Overview* which had been published on the Society's website.

The General Secretary Chaired the Meeting.

1. Minutes of the Annual Business Meeting of the Pathological Society of Great Britain and Ireland, held on 2 September 2020.

The minutes were accepted by the Meeting (and included in the Agenda circulated to all Members). Proposed by Prof GI Murray and seconded by Prof S Coupland (post hoc).

2. Matters arising from the Minutes.

There were none.

3. Elections.

The results were announced at the end of the meeting (see item 10 on page 13).

- 3.1 Ordinary Committee Members.
- 3.2 Trainees' Sub-Committee.

Noted:

- i. The original call for Trainees' Sub-Committee nominations was for 1 vacancy, but as the Committee agreed to change the By-Laws to increase the maximum number of Sub-Committee Members from 10 to 11 and to have a Vice Chair, there are 2 vacancies to be filled.
- 4. **President's Report.** (Prof AM Flanagan)
- 4.1 COVID-19 Pandemic.

Noted:

- The remit of the Society is that it is dedicated to enhancing high quality research and education in pathology in its broadest sense.
- ii. In stepping down as President, I think we can be reasonably satisfied that we are fulfilling our remit but there is always more to be done.

- iii. Good research requires training in the right environment. In the last few years we have seen unprecedented numbers of trainees in PhD studentships. Many of the successful candidates have been awarded Pre-Doctoral Research Bursaries and we would encourage more people to take these opportunities.
- iv. We have seen increases in Lecturers and Intermediate Fellows and Summer Studentships for medical students, who are our future, so we should engage with medical students and showcase pathology to them.
- v. The National Academic Trainee Network Meetings continued to be led by Prof P Quirke and the President thanked him for his support.
- vi. Some of the PhD Fellowships and Lecturers have come from the MRC, Wellcome Trust and CRUK, but most of the successful increase in trainee academics can be attributed to the jointly funded Jean Shanks/ Pathological Society schemes. We have jointly committed £5million to research and education, with the stipulation that it must be high quality research.
- vii. Research is being performed in many units, centres, departments and institutes across the UK, but there are still pockets which require some investment in terms of appointments and recruitment.
- 4.2 Links with other Professional Bodies.
- 4.2.1 The Jean Shanks Foundation.

Noted:

The President thanked Prof Sir Nicholas
 Wright and Prof Sir James Underwood, who
 both played a major role in the supporting
 the Path Soc for many years and are also

Trustees of the Jean Shanks Foundation and they should be recognised for their continued support.

#### 4.2.2 BDIAP.

Noted:

- i. The other most important relationship is with the BDIAP with which we hold the Summer Meetings and the President thanked Prof H Grabsch and Prof MJ Arends for their hard work and efforts in bringing the Manchester Pathology 2021 meeting to fruition despite the challenges of COVID-19.
- ii. The President thanked the Council and President of the BDIAP for being part of our mutually beneficial partnership.

#### 4.3 ACCEA.

Noted:

The Society actively supports ACCEA applications.

The President wished Prof MJ Arends luck when he takes up post as President after the AGM today.

We had welcomed Dr Ali Khurram onto the Committee as a newly appointed Webmaster and Digital Adviser. Dr Khurram has made a big difference and is overhauling the Society website.

The President also welcomed Dr Vivienne Parry onto the Committee as Lay Representative who replaced Sue Armstrong.

The President thanked all the Members of the Committee who she had worked with over the past three years, and she stated that it had been great fun and she had really enjoyed it.

The President also thanked Ros Pitts and Julie Johnstone, as we couldn't do without them.

The General Secretary thanked the Professor Flanagan for her report.

#### 5. General Secretary's Report. (Prof MJ Arends)

### 5.1 Society Lectures, Medals and Awards – Call for Nominations:

Noted:

i. The General Secretary reminded those present of the deadlines for the Society's Awards as listed below and encouraged Members to submit nominations for worthy candidates and referred Members to the General Secretary's Notes on the Agenda:

#### 5.1.1 2022 Doniach Lecture and Award.

Application/nomination deadline: 1 December 2021.

### 5.1.2 2022 CL Oakley Lecture and Medal.

Application/nomination deadline: 1 December 2021.

#### 5.1.3 2022 Goudie Lecture and Medal.

### 5.2 Membership.

Noted:

- i. Numbers had decreased slightly to 2021 (as at June 2021) from 2253 (at September 2020).
- ii. We had seen more Concessionary Members who were converting to Ordinary Members.
- iii. We are seeing variation in numbers of Undergraduate and Associate Foundation Doctor Membership which has caused the small reduction in total membership, almost certainly related to COVID-19.

### 5.3 Associate Undergraduate Membership. Noted:

- i. The Undergraduate Network is now fully embedded in the Society's Mission.
- ii. The General Secretary thanked Amber Matkowski as Chair and Roberta Turner as Vice Chair of the Undergraduate Sub-Committee.
- iii. The membership currently stands at 426.
- iv. The General Secretary reminded the meeting that Undergraduate Membership is free of charge and encouraged them to notify their students about this.
- v. The General Secretary thanked Dr Gemma
  Petts who had agreed to be Undergraduate
  Lead for the Society and has been working
  hard in encouraging students to get involved
  in undergraduate activities for the Society.

### **5.4 Foundation Doctor Associate Membership.**Noted:

- i. This membership was introduced in 2018/19 and currently stands at 83.
- ii. This membership is also free of charge and Undergraduate Members convert to Foundation Membership when they graduate.
- iii. Members were encouraged to promote this within their medical schools to encourage Student Members to remain with the Society.

Prof R McMahon had announced that a few members weren't able to join the AGM as the link provided in the AGM Agenda didn't appear to work/connect to the AGM.

It was not known why this had happened, but the email circulated to all Members this morning contained the link which provided a functioning link which allowed Members to attend the AGM.

### 5.5 Special Resolution.

Proposed Amendment to Articles 22 and 23 (page 13) and Article 33 (a new/additional Clause – subsequent Clauses have been renumbered accordingly (as outlined within the AGM Agenda documents).

Noted:

- The purpose of these proposed amendments is to allow flexibility in order that the Society may hold AGMs virtually as necessary.
   The Government had granted temporary permission for AGMs to be held virtually due to the pandemic and enforced home-working rules, but this may not continue.
- ii. There are minor changes to 22 and 23.
  23.2 states that if an electronic meeting is held, the Members must be provided with the information to access/attend the meeting and the person shall be considered as attending if they can hear the Chair speaking and have the ability to vote.
- iii. New Clause 33 comprises 8 Sub-Clauses which were summarised as follows:
  - 33.1 Sets out that we may hold a physical (in-person) meeting, an electronic or virtual meeting, or a combination of the two (hybrid meeting).
  - 33.2 Sets out that we must provide suitable electronic means for Members to be able to hear the Chair and to be able to vote.
  - 33.3 Provides for sufficient information for Members to access an electronic meeting.
  - 33.4 States that all Resolutions must be put to a vote by an electronic poll of some means.
  - 33.5 States that all other provisions in the Articles still apply.
  - 33.6 Sets out what we would do in the event of technological failings.
  - 33.7 Concerns the proof that the people joining can be identified as Members of the Society.
  - 33.8 Sets out matters of etiquette, communication and voting.

Following an opportunity for questions (there were none), the General Secretary asked those present to vote if they had not already done so, either for or against the Special Resolution using the link to the voting system that had been provided in the documentation and circulated again this morning.

Should members wish to abstain, they were advised not to vote.

The results of the vote to be announced at the end of the meeting.

### 5.6 Website Strategy.

Noted:

- The General Secretary endorsed the President's thanks to Dr Ali Khurram, University of Sheffield, the Society's Webmaster and Digital Adviser.
- ii. Dr Khurram had worked very hard together with Ros Pitts and Julie Johnstone in redesigning the website and membership management system to be launched soon.
- Members were reminded to check their details when asked.
- iv. Dr Khurram has also assisted in managing the Pathology Grand Round Lectures and setting up the new Grant Management System.

#### 5.7 Other matters.

Noted:

- The monthly Pathology Grand Round Lectures initiative introduced by the President in January 2021 as a series of lectures have been very successful and well attended.
- ii. They are co-sponsored by the Jean Shanks Foundation, for which we thank them.
- iii. As the President is stepping down, a PGR Executive Group has been set up to arrange future lectures by highly respected speakers.
- iv. The next lecture will be given by Dr David Adams, Wellcome Sanger Institute, Cambridge, on 15 September 2021.

Questions were invited – there were none.

6. Treasurer's Report and Appointment of Auditors. (Prof GI Murray)

### 6.1 Review of the Year 2020

Noted:

- i. Finances of the Society are in an entirely satisfactory state and despite the events of last year, we report an overall small surplus of just over £19,000 taking into account realised and unrealised investment gains and losses.
- ii. Income from the *Journal of Pathology* increased although the capital value of our investments not surprisingly decreased and commensurate with that our investment income decreased.
- iii. Looking at 2020 income, this came from the *Journal of Pathology*, investments and

subscriptions, with the *Journal* being our most important source of income, which showed an increase from 2019 due to a combination of a slight increase in profit share as a result of our new agreement with Wiley, as well as a reduction in costs.

- iv. It was worth noting that total licensing income from the *Journal* had decreased and may be indicative of the road of travel we are on with the *Journal*.
- v. Also worth noting that our very successful fully Open Access *Journal of Pathology:*Clinical Research is continuing to expand and what that contributes to Society income.
- vi. Investment income is down and expected to stay down, which is not surprising given the COVID-19-related events of 2020.
- vii. There had been healthy expenditure on grants.
- viii. As expected we had less expenditure on meetings and events.
- ix. Subscription income has slightly increased although reliance on subscription income would mean an entirely different Society.
- x. Going forward we must be mindful of the value of our investment portfolio, the likelihood of ongoing loss of investment income and the various grant expenditure incurred in order for people to continue with their grant projects. We also need to be aware of the continued potential effects of Open Access Publishing on the income of the *Journal of Pathology* and keep this under review.

#### 6.2 Investment Management.

Noted:

 Cazenove, our Investment Managers, continue to provide an entirely satisfactory service and we don't propose any changes to that.

### 6.3 Grant Scheme Budgets.

Noted:

i. These are on track and we continue to make a very substantial contribution to research.

### 6.4 2022 Membership Subscriptions.

Noted:

i. The proposed fees for 2022 to be maintained at current rates, i.e.:

Ordinary: £60 Concessionary: £10

Journal of Pathology (online only): £45
Journal of Pathology (online + print): £65
Diagnostic Histopathology (online + print): £153

### 6.5 Accounts for the year ended 31.12.20

### - for the Pathological Society to seek acceptance and approval.

Noted:

- i. The abbreviated accounts (see pages 18–22 of this booklet) had been circulated with the Agenda.
- Prof MJ Arends proposed that the accounts be accepted and Prof AM Flanagan seconded the proposal.

### 6.6 To re-appoint Accountants/Auditors.

Noted:

- Raffingers who provide a satisfactory service and it was proposed that the Society reappoint Raffingers.
- ii. Prof AM Flanagan proposed this and Prof SE Coupland seconded the proposal.

### **6.7 Pathology London 2014 Ltd** – *striking off.* Noted:

 This has now been struck off and we can create another subsidiary in the future if required.

#### 6.8 Other matters.

Noted:

i. The Treasurer thanked Ros Pitts and Julie Johnstone for their very effective running of the Society, especially over the last year.

Questions were invited:

- Q: Had the investments recovered since the year end?
- A: The capital value of our investments had returned to their pre-Covid-19 level, currently around £7.8 million and we will be faced with a decrease in investment income because of company performances over the next 2–3 years.

The General Secretary thanked the Treasurer for his report.

### 7. **Meetings Secretary's Report.** (*Prof HI Grabsch*) Noted:

 The 2021 Winter Meeting was cancelled due to the Covid-19 situation.

### 7.1 2021 Winter School and Future Winter Schools. Noted:

- i. This week-long training course was fully virtual and very successful.
- ii. The course will continue with the format remaining as a virtual event or as hybrid. It generated a profit this year which had helped offset losses of the past couple of years.

### 7.2 Manchester Pathology 2021, Virtual Event, 6-8 July 2021 (13<sup>th</sup> Joint Meeting of the BDIAP and the Pathological Society).

Noted:

- This is the first meeting where we have engaged a professional conference organiser (CPI) to manage the whole event.
- ii. This is our first virtual meeting, so we had tried new ideas and we will evaluate the feedback.
- iii. HG thanked Dr Lisa Browning and her colleagues at the BDIAP and MJA for their hard work in organising the meeting.
- iv. HG thanked Ros Pitts and Julie Johnstone for their help despite the difficult circumstances.

### 7.3 2022 Winter Meeting, London, 25–26 January 2022 (4<sup>th</sup> Joint Meeting with the RSM).

Noted:

- We are planning a hybrid/blended format with on-site attendance and live streaming; meetings rooms have been booked at the RSM, although we may not manage to fill the rooms.
- ii. Prof M Ilyas and Dr A Mukherjee, Nottingham, have agreed to help organize the programme which is already being prepared.
- iii. The promotional flyer was shown during breaks during MP2021.
- iv. The location will be Royal Society of Medicine, London and is a Joint Meeting with the RSM.

### 7.4 2022 Joint Meeting with the BDIAP (1st week of July 2022).

Noted:

i. We are planning a hybrid style event within the UK, location to be determined.

Questions were invited – there were none.

The General Secretary thanked Prof Grabsch for her report.

### 8. Sub-Committees – Chair's Reports.

### **8.1 Education Sub-Committee.** (*Dr A Mukherjee*) Noted:

- i. 2020 was a unique year which created educational challenges.
- ii. As a Society we thank all pathology educators who continued to champion pathology education in the most trying of times.
- iii. We would ask Members to promote the Society's grant schemes amongst their students and deaneries.

- iv. Intercalated Degree Awards: In 2020, three applications were funded. A second deadline was introduced in October and one application was received and funded. In 2021 we funded six applications in the March round.
- v. The 2022 Winter School attracted 127 delegates from the UK and EU and we continue to support this course.
- vi. Undergraduate Elective Bursaries:
  In 2020 we had supported twelve applications but only four had been completed due to Covid-19. We were only able to select one report prize (Research) as there were so few.
- vii. Undergraduate Essay Competition 2020 was won by Precious Julagbo, University of Leeds. The 2021 prize deadline is 31 August Members were asked to encourage their students to enter.
- viii. Student Society Scheme, Education Grant Scheme and Golden Microscope Awards received no applications in 2020.
- ix. The Golden Microscope Award has been opened up for the 2022 Winter Meeting as well.
- x. The first Paola Domizio Best Undergraduate Abstract Prize was awarded to Maximilium Kloft, GROW School of Oncology, Maastricht. The prize will be given at both Summer and Winter Meetings and was created in memory of Paola Domizio, who was the first Chair of the Education Sub-Committee from 2004 to 2008.
- xi. The Jean Shanks/Pathological Society Summer Studentships were introduced in 2020 for Year 1 or Year 2 medical or dental students working with research active consultant pathologists, or medically or dentally qualified clinical lecturers, or equivalent Path Soc Members may apply to this scheme for their student. The application deadline has been removed and applications are accepted on a rolling basis to simplify this process for the applicants.
- xii. Future objectives are to be as flexible as possible with our grant funding following the COVID hit. The Treasurer had agreed that unspent budget from 2020 can be utilized to fund additional applications in the current rounds.
- xiii. A new Teaching and Learning Workshop is planned for November to assist pathology educators with managing digital teaching methods.

- xiv. We continue to contribute to the Winter Meeting and to the MSCAA examination questions.
- xv. We continue to assist with the Mentoring Scheme and Society Ambassadors which now include Foundation and Undergraduate engagement and to maintaining our online educational resources.
- xvi. The Trainee and Undergraduate Sub-Committees have done a lot of work on the Mentoring and Managing Regional Coordinators and we thank them for their hard work.

AM thanked Dr Emyr Benbow, his predecessor, also Dr Guy Betts and Dr Liz Soilleux who will retire from the Committee today.

AM also thanked the whole Committee as well as Ros Pitts and Julie Johnstone for their support throughout the year.

Questions were invited - there were none.

The General Secretary resident thanked Dr Mukherjee for his report.

### 8.2 Research Sub-Committee.

(Prof GJ Thomas was unable to attend, Prof MJ Arends reported on his behalf) Noted:

- i. MA presented a slide provided by Gareth
  Thomas and gave a verbal report of the
  contents.
   (refer to the 'Overview of the Year' Appendix A)
- ii. The total spending on Path Soc Research Grants in 2020 was approximately £475,000.
- iii. The total spend for JSPS Grants in 2020 was approximately £728,000.
- iv. For the jointly funded Jean Shanks/
  Pathological Society Schemes, of the original £5 million joint budget, the funds committed up until the end of 2020 were just over £2.2million. With the addition of the April 2021 round this amounts to £2.7 million.
- v. A new JSPS Scheme will be introduced this Autumn: the *Clinical Post-Doctoral Fellowship*. GT is working on the documentation and further details will be posted on the website in the next month or two.
- vi. Trainees were encouraged to consider applying to these schemes as appropriate.
- vii. Our jointly funded CRUK Pre-Doctoral Research Bursary scheme funded two applications in 2020 for a total of

- approximately £81,000. The General Secretary and Prof Thomas had met with CRUK representatives and the agreement would be extended until 2023.
- viii. Despite the issues surrounding Covid-19, we received a good number of applications in 2020, with 22 in the Spring round and 33 in the October round. The Research Sub-Committee was pleased with the overall quality of the applications.
- ix. We thank the CRUK and Jean Shanks Foundation for their collaborative grant funding.
- x. Prof Thomas thanked Julie Johnstone and Ros Pitts for their help and support and apologised for his absence.

Questions were invited - there were none.

The General Secretary thanked GT for providing the information.

### 8.3 Molecular Pathology Sub-Committee.

(Dr M Jansen)

Noted:

- MJ had taken over from Manuel Salto-Tellez in January as Acting Chair and takes over as full Chair at the end of the AGM.
- ii. Several initiatives have been carried over and most important is to explore alignment between the various Societies, the Royal College and the BDIAP, and in particular regarding our funding schemes. We hope to make this more visible and clear for trainees. This has been done together with Prof SE Coupland.

Questions were invited - there were none.

The General Secretary thanked Dr Jansen for his report.

### 8.4 Trainees' Sub-Committee.

(Dr C McGenity on behalf of Dr K Marks) Noted:

- Dr McGenity was the new Vice Chair of the Sub-Committee and reported on behalf of Dr Kate Marks (Chair) who is on maternity leave.
- ii. We continue to write Case of the Month papers for *Diagnostic Histopathology*.
- iii. This year we held the Trainee Research Forum Lectures, from February–April as monthly lunchtime meetings, to encourage trainees to engage and present. This may be relaunched if face-to-face events remain difficult.

- iv. The Academic Mentorship Scheme has been relaunched with approximately 30 new members this year and a training session has been arranged for next week.
- v. We are working with surgical colleagues to provide pathology education training aimed at surgeons and junior pathology trainees with ASiT.
- vi. We continue to arrange the ST1 Introduction to Academic Pathology Day which was held virtually last year and will be virtual again this year.
- vii. We have organised Trainee Sessions for the MP2021 Meeting and are planning similar sessions for the 2022 Winter Meeting.
- viii. We help to plan and run the National Academic Trainee Network meetings which have been held virtually during the pandemic.
- ix. Our Twitter account has an increasing reach and we now have an Instagram account and use WhatsApp groups for NATNM and in-person meetings and the Academic Trainee Path Soc website continues to be accessed internationally.

CM thanked all of the TSC Members for their hard work this year and particular to Kate Marks as Chair and to Ros Pitts and Julie Johnstone for all their help.

The General Secretary thanked Dr McGenity for her report.

# 9. Editor's Reports – Journal of Pathology and Journal of Pathology: Clinical Research (Prof CS Herrington)

Prof Herrington referred Members to the full report in the *Overview* document on the website.

### 9.1 Review of the year (a) – *Journal of Pathology* Noted:

- i. The new Impact Factors (IF) were released last week and JPath has risen to almost 8 from just over 6 although some of this is due to the change in the method of calculating the IF. This is true for many journals, although not all journals acknowledge this as part of the reasons for the increase.
- ii. Importantly our ranking in the Pathology field remains unchanged at number 5 and we have the top rank for general pathology research journals, the 4 above us are 2 review journals and 2 neuropathology journals, and we are very close to the neuropathology journal just above us, so a good all round outcome.

- iii. Issues are published and delivered on time.
- iv. We have had some operational challenges with Wiley and we are in discussion with the Society about this.
- v. One reason why the IF remains strong is the Annual Review Issues (ARI) which are now focusing on recent advances in pathology rather than being specifically themed, are much better cited than in recent years. 2020 was the best cited for 7 years, partly as it includes a review on aspects of SARS-COV-2. The 2021 issue was published this month, slightly later than planned largely due to Covid.
- vi. The Treasurer has alluded to future potential issues with income, Open Access being one factor likely to affect this. This year Clarivate have published Gold Open Access proportions for each journal as well as IFs. *Journal of Pathology* is performing well at 34% Open Access but this represents a financial threat although it is positive from the view of Open Science.
- vii. We've had quite a few Covid papers, some which have been reviewed and one or two of which we have published. We have noticed an effect on the ability of authors, particular if they are asked to revise their manuscripts and been asked for additional experiments.
- viii. Submissions are starting to rise again possibly as labs begin to re-open.
- ix. All in all a positive message.

### 9.1 Review of the year (b) – Journal of Pathology: Clinical Research

Noted:

- i. The IF has increased from approximately 3.5 last year (its first IF) to 6.8 and importantly our ranking position has changed from 20 to 12 in the Pathology field and we have leapfrogged several other journals.
- ii. There has been an increase in the number of direct submissions probably due to the IF.
- iii. Operational challenges are also an issue with Wiley.

### **9.2** The Jeremy Jass Prize for Research Excellence. Noted:

i. The 2019 winning paper, was awarded in 2020 was for: "Inter- and Intra-Tumoural Heterogeneity in Cancer-Associated Fibroblasts of Human Pancreatic Ductal Adenocarcinoma", C Neuzillet et al.

- ii. The recent number of citations on Google is almost 100.
- iii. This demonstrates the kind of paper we receive with very large numbers of authors and multi-disciplinary input to integrated papers.

CSH thanked the Associate Editors and Wiley colleagues who worked very hard through the pandemic to continue the publication.

The General Secretary thanked CSH and Dr Richard Poulsom for their sterling work on the *Journal* which remains very successful.

Questions were invited – there were none.

#### 10. Election Results.

- i. Prof AM Flanagan now retires as President.
- ii. The General Secretary retires and takes up office as President.
- iii. Prof Manuel Salto-Tellez stepped down as Chair of the Molecular Pathology Sub-Committee and has been succeeded by Dr M Jansen.

### 12. Any Other Business.

The General Secretary gave a special thanks to Prof Adrienne Flanagan for her three years as President; she had done a sterling job with clear leadership.

Adrienne had started a number of new initiatives including the very successful Pathology Grand Rounds and played a key role in initiating three or so of the new JSPS Funded Grant Schemes.

She continues as a Trustee of the Jean Shanks Foundation and the General Secretary was sure that she will continue to play a very important role in both the JSF and the Pathological Society supporting on-going research.

The General Secretary thanked AF again on behalf of the whole Society.

### Special Resolution (Item 5.5) - Results of Vote.

There were 47 votes agreeing to the change which meets the requirements for successfully carrying the Resolution (the meeting being quorate at >20 attendees).

There being no further business, the meeting was terminated at 13.55 hrs.
